**ORDINANCE RELATING TO ADMISSION AND EXAMINATION FOR
BACHELOR OF PHYSIOTHERAPY (B.P.T.) COURSE
IN THE FACULTY OF MEDICINE**

1. This is a degree in the Faculty of Medicine and shall be designated as "Bachelor of Physiotherapy" and shall be abbreviated as "B.P.T."

2. AIM OF THE COURSE

The aim of the course is to impart in depth the theoretical basis as well as the therapeutic skills in art and science of Physical Diagnosis and Physiotherapeutic, so that one can practice the profession in a competent manner towards those who need such services, with autonomy in quality, care assurance and maintaining the humanitarian approach of service with compassion.

The training programme shall be framed to meet the following specific objectives.

- i) Acquisition of adequate theoretical and practical knowledge in the basic medical subjects.
- ii) Proficiency in the skills of basic Physiotherapy procedures and techniques with adequate theoretical basis of allied sciences.
- iii) Ability to detect Patho-physiotherapy impairment of structural and functional deviations by using methodology of physical diagnosis to evaluate the disability prognosis.
- iv) Competency in imparting the physio-therapeutic measure of specific choice towards preventive, curative, symptomatic and restorative or rehabilitative goals.
- v) Acquisition of moral and ethical codes and conduct of professional practice in a dedicated manner with the patient welfare as the primary responsibility.

3. ADMISSION TO THE COURSE

- (i) No candidate shall be admitted to B.P.T. course unless he has passed 12th standard of 10+2 or B.Sc. Part I (3 Year degree course, Old Pattern, 11+3) examination of any of the recognized Board / University with Physics, Chemistry and Biology (Zoology and Botany) or any equivalent examination there to. Candidates must have passed in these subjects in theory and practical separately. Foreign nationals seeking admission will be duly considered on the basis of equivalence certificates granted to them by the concerned University or as stated by the External Affairs Ministry.



- (ii) No Candidate shall be admitted to B.P.T. course unless he has completed the age of 17 years on or before 1st July of the year of admission.
- (iii) No Candidate shall be admitted to B.P.T. course unless he has secured 50% marks at the above-mentioned qualifying examination, in aggregate of Physics, Chemistry and Biology (Zoology and Botany) subjects. A relaxation upto 5% marks shall be allowed in this minimum percentage of 50% for SC/ST/OBC candidates.
- (iv) The total number of seats in a college shall be decided by the University. However this number shall not exceed 60. There can be additional 5 N.R.I. seats, if permitted by the University. The directives of the M.P. Govt., if any, shall be followed in deciding the number of seats.
- (v) Reservation in seats for SC/ST/OBC candidates shall be as per the policy of M.P. Govt. regarding reservation of these categories in medical colleges of the state.
- (6) The admission to B.P.T. course can be through a written entrance examination or on the basis of marks at the qualifying examination in the three subjects mentioned above. Either of these modes of admission shall be decided by the Executive Council of the University.

4. FEES

- (a) Tuition fees etc. to be charged by the college from a student shall be that decided by the College.
- (b) Examination fees to be charged by the University from a student for a University Examination shall be that decided by the Executive Council of the University.

5. DURATION OF COURSE, TRAINING PERIODS AND TIME DISTRIBUTION

Every student shall undergo a period of certified study extending of 4 academic years (48 Months) from the date of commencement of his study for the subjects comprising the B.P.T. curriculum to the date of completion of the fourth year examination and followed by six months compulsory rotating full time internship.

6. EXAMINATIONS

(1) UNIVERSITY EXAMINATIONS

Examination shall be conducted by the University as follows.

- (i) B.P.T. First year Examination at the end of 1st Year
- (ii) B.P.T. Second year Examination at the end of 2nd Year
- (iii) B.P.T. Third year Examination at the end of 3rd Year
- (iv) B.P.T. Fourth year Examination at the end of 4th Year

(2) ATTENDANCE

Minimum 75% attendance in theory and minimum 75% attendance in practical in each subject is necessary for appearing at a University examination, as a regular students of the College of Physiotherapy, which possesses a Hospital of its own and /or has a tie up with a Hospital.

(3) INTERNAL ASSESMENT

- (i) It shall be based on day to day assessment, evaluation of student's assignment, preparation for seminars, clinical case presentation etc.
 - (ii) Regular periodical examination shall be conducted throughout the course.
 - (iii) Day to day records should be given importance during internal assessment.
 - (iv) Student must secure at least 50% of the total marks fixed for internal assessment in all the subjects taken together for a University examination in order to become eligible to appear in that University examination.
- (4) ~~There will be only yearly examinations. There will be no supplementary examinations.~~

APPOINTMENTS OF EXAMINER

- (i) No person shall be appointed as an examiner in any of the subjects of the B.P.T. examination unless he has a doctorate or M.D. or M.S. Degree or he has Masters Degree in Physiotherapy of a recognized University or an equivalent qualification in the particular subject and has had at least five years of total teaching experience in the subject concerned, in a (Allopathic) Medical College or a College of Physiotherapy, affiliated to a recognized University, as a regular faculty position. A regular teacher, not below the rank of Reader, teaching allied subject in a (Allopathic) Medical College may also be appointed as examiner.

- (ii) In a theory paper, where there are two sections, two separate paper setters will be appointed for the two sections. The answer books shall be separate and they will be evaluated separately, by the respective paper setters.
- (iii) ~~As far as possible at least 50% examiners in theory papers will be from outside the University.~~
- (iv) For practical and oral examinations one external and one internal examiner will be appointed for each subject. External examiner will be from outside the University.

Only full time regular teachers of the concerned Collegē, possessing the minimum qualifications as laid down to become an examiner, shall be appointed as internal examiners. If there is no such teacher available in the College, then two external examiners will be appointed, one of which will be designated as internal.

The marks for practical and oral examinations shall be awarded jointly by the internal and external examiners.

- (v) For the subjects of Sociology and Bio-Statistics, Psychology, Bio-mechanics and Bio-engineering and Computer Science, teachers, who are not serving in a (Allopathic) Medical College or a College of Physiotherapy, may also be appointed as examiners in these subjects, provided they are well conversant with the subject and who have at least 5 years teaching experience in Universities/ Colleges

9. INTERNSHIP

Just after passing all the four B.P.T. examinations, a student has to undergo six months compulsory rotating full time internship.

A student shall become eligible for the award of the degree of B.P.T. only after a certificate from the Principal of the College along with a certificate from the Incharge of the Institution / Hospital, is sent to University that the student has completed six months internship in an Institution / Hospital recognized by the Standing Committee of the Academic Council of the University. For such recognition, the College has to apply to the University giving details of the Institution / Hospital. The directives of the M.P. Govt., if any, shall be followed in deciding the Institution / Hospital where the student will undergo internship.

10. RULES FOR PASSING IN UNIVERSITY EXAMINATION

(i) Internal Assessments

- (a) Weightage for internal assessment shall be 25 marks in each subject.
- (b) Student must secure at least 50% of the total marks fixed for internal assessments in all the subjects taken together for a University examination in order to become eligible to appear in that University examination.

(ii) Minimum marks for passing in University examination

For passing a university examination, in each subject, a candidate must obtain

- (a) 50% marks in Aggregate.
- (b) 50% marks in Theory paper and viva taken together.
- (c) 50% in Practical.

(iii) Grace marks

A total of 5 grace marks may be given to a student in any subject/ subjects in a University examination for passing in Theory paper (including viva) or Practical (not in internal assessment) examination.

(iv) Results

The Marksheet shall mention the result as "Pass" or "Fail" (Not as "Supplementary"). No Division shall be awarded. However, merit list shall be prepared, after the student has passed all the four examinations, on the basis of total marks obtained in all the four examinations.

(v) A student Failing in maximum two subjects

- (a) A student who fails in a maximum of two subjects in a University examination may be admitted to the higher class and can also appear in the examination of the higher class.
- (b) Such a student will have to appear in the examination to be held next year in the papers in which he has failed in the lower class. He will have to fill the examination form of the lower class and pay full fees prescribed for the examination.
- (c) His result of the higher class shall be declared as "Withheld" (W.H.)
- (d) After he has passed in the subjects in which he has failed in the lower class, only then his result of the higher class shall be declared.

II. GENERAL RULES FOR UNIVERSITY EXAMINATION

- (i) Result of all University examinations shall be declared before the start of teaching for next year
- (ii) The examination should be planned in such a way that the total period for any examination/ including declaration of result does not extend beyond one month.

- (iii) The vacation period to students in one calendar year should not exceed one month during the 48 months B.P.T. course.
-
- (iv) The medium of examination shall be English.
- (v) A student has to be enrolled in the University as per University rules.
- (vi) These will be no moderation of theory papers.
- (vii) Revaluation of the University examination answer books of the theory papers shall be done as per University rules

12. SYLLABUS

The syllabus shall be as prescribed by the Board of Studies.

Provided that till the time syllabus is prescribed and finalized by the University bodies, the syllabus of Devi Ahilya University, Indore, shall be followed.

13. REQUIREMENT TO BE FULFILLED BY THE COLLEGE

The requirement of: -

- (a) Teaching staff.
- (b) College building.
- (c) Laboratory facilities.
- (d) Hospital facilities.

shall be the same as prescribed by the M.P. Govt., if any. Otherwise, the requirement will be the same as prescribed by the University. Till the time the requirements are prescribed by the University, the requirement shall be the same as prescribed by Devi Ahilya University, Indore.

14. DISPUTES

Any dispute arising out of this ordinance or otherwise shall be decided by the Executive Council of the University, whose decision shall be final.

Ordinance and Regulations relating to the Degree of Ayurveda Vachaspati-M.D.(Ayu)
(Doctor of Medicine-Ayurveda)

1. AIM AND OBJECTIVE

The aim of the Post-graduate degree course shall be the orientation in specialities and super specialities and to produce experts and specialists who can be competent and efficient teachers, clinicians, surgeons, pharmacysts, research workers and profound scholars in the respective field of specialisation of Ayurveda.

2. SPECIALITY IN WHICH POST- GRADUATE DEGREE IS CONDUCTED

3. THE NOMENCLATURE OF POST- GRADUATE DEGREE

Ayurveda Vachaspati. M.D. Ayurveda (Rachana Sharir)

4. ELIGIBILITY

1. The degree in Ayurveda of this University or of those University/Statutory institutions which are recognised as equivalent by Central Council of the Indian Medicine & Homeopathy New Delhi.
2. Only those who have passed all the examinations at degree level in first attempt shall be eligible for admission.

5. MODE OF ADMISSION

(1) There shall be an Admission Committee consisting of following.

- (2) The Selection shall be made strictly on the basis of one common final merit index based on written test and interview as follows :-
 - (a) Written Test Index (to be calculated out of 90 marks)
 - (b) Interview Index (to be calculated out of 10 Marks)
 - (c) Final merit Index (100 marks)
- (3) The minimum marks in the final merit index for eligibility for admission shall be 50% (40% in the case of reserved categories).
- (4) The written test shall consist of one common written paper comprising of objective type of questions and covering all the subjects of Ayurveda, the details of which shall be decided by the Admission Committee constituted as above.
- (5) The number of the candidates to be called for interview (on the basis of the marks obtained in the written test) shall not exceed three times the number of seats advertised. The same rule will apply to SC/ST quota also.
- (6) The names of the candidates for Interview will be intimated to the Admission Committee which shall interview the candidates without indicating the marks obtained in the written test.

6. PERIOD OF STUDY AND ATTENDANCE

- (1) The candidates have to undergo a period of study for three years after admission, out of which one year shall be devoted to Preliminary course and next two years devoted to Speciality Course.
- (2) The students will be required to attend 75% of total lectures, practicals and clinicals separately to become eligible to appear in the examination
- (3) The students will be required to attend the hospital and other duties as may be allotted to them during the course of study. All the students will be required to do House Job duties and clinical Registrar's duties in their respective departments during preliminary and final courses respectively.
- (4) The students will also be required to attend special lectures, demonstrations, seminars, study tours and such other activities, which may be arranged by the teaching departments.
- (5) No relaxation in period of study shall be given to a candidate who have already obtained Post-graduate degree in one speciality and thereafter desires to undergo post-graduate course in other speciality.

- (6) The teachers having a three years teaching experience can be allowed to undertake Post-graduate training as regular candidate. No relaxation in the duration of study will be made to inservice physicians/teachers.

7. METHOD OF TRAINING

- (1) Intensive training will be given in classical knowledge alongwith comparative and critical study in the respective speciality.
- (2) The emphasis should be given on in-service training and not in didactic lectures.
- (3) The candidates are required to know about the method and technique of research work done in the respective fields
- (4) The candidate should be required to participate in the teaching and training programmes of Under-graduate students or interns in their subjects.
- (5) In the first year period the emphasis should be given to give adequate knowledge in the applied aspects of the fundamental of all the subjects of Ayurveda and adequate training in the basic science of medicine in all its applied and comperative aspects relevant to the speciality concerned with special reference to the fundamentals of Ayurveda.
- (6) The clinical training should aim to extend the knowledge of the candidate to undertake independent work as a specialist.
- (7) The thorough and intensive training on a planned programme should be given to the students during all stages of the course and such programme should be available for the inspection and scrutiny of the Central Council of Indian Medicine.
- (8) Adequate training in teaching technology and reaserch methods should be undertaken during the course of studies.

8. THESIS

- (1) Before a candidate is allowed to undertake the work of thesis, the title of the thesis should be registered with the University within the six months of admission and the synopsis should be approved at the end of preliminary year.

- (2) The application of registration of the title of the thesis should clearly mention the full title of the thesis with a synopsis of the proposed scheme of work indicating the familiarity of the candidate with the proposed theme of work and the name of the department and the name and designation of the Guide/Supervisor and Co-guide.
- (3) Once the title for thesis is approved, the candidate will not be allowed to change the title or the proposed theme of work.

- (4) The registration of the candidate will be cancelled if the candidate fails to submit the title of thesis alongwith synopsis within the specified period as mentioned above.
- (5) No candidate shall be allowed to submit the thesis before the expiry of one calendar year after registration of the title of the thesis and before six months of the final year.
- (6) The subject of the thesis must be related with the subject matter of the speciality offered by the candidate.
- (7) The thesis should place on record the methods and potentiality of the research carried out by the candidate on the problem selected by him and completed under the guidance of the teacher approved by the University.
- (8) The thesis should consist of critical survey of relevant literature, research, results of the research, discussion on the basis of existing literature on the subject, conclusion, summary of thesis and references cited in the thesis.
- (9) There will be a Scrutiny Committee constituted by the University which will scrutinise and approve the title of the thesis and proposed scheme of work submitted as per rules. The subject of every thesis should be practical oriented devoid of unpromising specialities and should be helpful in the development of service of Ayurveda.
- (10) The thesis ordinarily consist of exceeding 200 typed pages. The thesis should contain at the end a Summary of not more than 1500 words covering the conclusion drawn by the candidate.
- (11) The Guide/Supervisor shall be a person of status of a Professor/Reader/Lecturer possessing at least five years Post-graduate teaching experience in the subject A Professor, a Reader and a lecturer can guide in maximum three, two and one students respectively in each academic year.
- (12) The thesis must be satisfactory as regards literary presentation and suitable for publication either as such as in an abridged form.

- (13) Four copies of the bound thesis together with one certificate from the guide must reach the office of the Registrar three months before the final examination.
- (14) The thesis shall be assessed by four examiners appointed by the University, two of them will be external and two internal. One of the internal examiners of the thesis should be the guide under whom the candidate has worked the thesis.
-
- (15) The thesis shall only be accepted after unanimous approval by the examiners appointed to examine it.
- (16) If the thesis is not accepted it will be referred back to the candidate with the remarks of the examiners and the candidate can resubmit the thesis, after making necessary improvements in the light of the examiner's report to the University, but not beyond a further period of six months.
- (17) The candidate shall be permitted to appear at Final Examination post-graduate degree in Ayurveda consisting of theory, oral and practicals including clinical, only after the thesis has been approved by the examiners appointed for the purpose.
- (18) One copy of the Synopsis of the title of thesis shall be submitted to the Registrar, Central Council of Indian Medicine as soon as the title is approved. One copy of the accepted thesis will be lodged in the library of the Central Council of Indian Medicine, New Delhi.

9. EXAMINATION AND ASSESSMENT

The post graduate degree shall have two examinations as follows :-

- 1- The Preliminary Examination at the end of one academic year after admission conducted by the University.
- 2- The Final Examination at the end of two academic years, after the Preliminary Examination.
- 3- The Final Examination will be held after completing two calendar years after passing Preliminary Examination and the candidates can avail of a maximum of two chances. The Final Examination will be held twice at an interval of six months.
- 4- No marks will be allotted in any part of the examination. Valuers should award 'Pass' or 'Fail'
- 5- Examination will ordinarily be held in the month of May-June and October-November every year.

- 6- For being declared successful in either the Preliminary Examination or the Final Examination the candidate shall have to pass all the theory papers separately and practical/clinical and viva voce examination separately.
- 7- If a candidate fails in one paper in the Preliminary Examination he shall have to pass in the paper before he is allowed to appear in the Final Examination
- 8- If the candidate fails in a theory paper and/or in practical/Clinical viva voce examination of either Preliminary or Final Examination, the candidate can to appear in the subsequent examination in the written papers and practical/Clinical viva voce examination without requiring to submit a fresh thesis.
- 9- The Post-graduate degree shall be conferred on the candidate after the acceptance of the thesis and after the candidate has passed the final examination in the speciality.

10. DETAILS OF EXAMINATION

I Preliminary Examination :-

- (1) The Preliminary Examination at the end of one academic year of admission shall be in the following papers

Paper I

Medical statistics and Research Methodology

Paper II

- (a) Fundamentals of Non-clinical subjects of Ayurveda with an emphasis on applied aspects alongwith relevant studies of fundamental of Basic Science of Medicine
- OR
- (b) Fundamentals of clinical subjects of Ayurveda with an emphasis on applied aspects alongwith relevant studies of fundamental of Basic Science of Medicine.
- (2) The candidate shall have to go the training in the department concerned for the speciality opted by the candidate as under :-
 - (a) Regular clinical training in the Hospital.
 - (b) Practical training of research work carried out in the department.
 - (c) Study of literature related to speciality.
 - (d) Active participation in various Seminars Symposiums and Discussions.
 - (e) Finalisation of Topic of thesis and synopsis thereof.

The assessment of the work done during the first year on the above points shall be done at the time of examination. For oral / viva-voce examination one external and one internal examiners shall be appointed.

I The Final Examination shall consist of

- (i) Thesis
- (ii) Written Papers
- (iii) Clinical,
- (iv) Oral / viva-voce and
- (v) Practical examination as the case may be

There shall be four theory papers in the speciality and one practical/clinical and viva-voce.

11. SYLLABUS

Syllabus for the course shall be as per Central Council & Indian Medicine.

2. Duration of Course :

The duration of the course of study for the P.G. Diploma will be a full time programme of one year. It shall extend over two semesters in one academic year. The course will commence in July every year. The number of seats, payment seats, reservation of seats and relaxation in admission criteria shall be as per university guidelines from time to time.

3. Eligibility for the Course :

Every candidate seeking admission to the P.G. Diploma shall have bachelor's degree required with 45% marks in aggregate in the relevant discipline of the Vikram University, Fiji or of any other statutory university recognized as equivalent thereto. Additional admission requirements for respective course if any, will be specified by the university from time to time.

Candidates, who have not obtained a Bachelor's degree at the time of application but appearing in the final year of a degree examination during the academic session, may also apply for admission. However, such candidates must produce evidence of passing the Bachelor's degree with at least 45% in aggregate by the date notified by respective departments / university; failing which their application will not be considered for admission.

4. Subject to the requirements of admission indicated above, admission to the programme shall be on merit determined on the basis of entrance examination / procedure specified by the university from time to time.
5. The admission fee, tuition fee, examination fee and other fees shall be specified by the university from time to time.
6. The P.G. Diploma shall consist of two semesters and there shall be a University examination at the end of each semester. The semesters shall run consecutively.

7. A candidate shall be eligible to appear in the second semester examination only after having passed the first semester examination.
 Provided that if a candidate fails in not more than two theory papers in first semester examination but having passed in internal assessment examination of all papers of that semester shall be eligible to carry ATKT in the papers in which he has failed and to take examination of the ATKT papers along with the next identical semester examination only. Such candidates shall be admitted to the second semester and their result of second semester would be declared only after having cleared first semester. A candidate failing in not more than two theory papers in second semester shall be eligible to take examination of those paper along with next identical semester examination. The result of such candidates of second semester would be declared as "Fail in one/two papers".
8. If a candidate fails in internal assessment of even one paper, of any semester he will be declared fail.
9. A candidate will be declared fail in a semester if he fails in more than two theory papers of that semester examination. And if he has passed in internal assessment of all the papers of that semester, he will be allowed to appear as ex-student in the next identical semester examination. His marks of internal assessment project shall be carried over.
10. A candidate seeking admission in first semester will be required to complete the course within a span of three academic years.
11. The course of study for each semester shall be as per the scheme provided in the prospectus. These will be subject to the changes from time to time by the university.
12. The internal assessment shall consist of tests, quizzes, assignments, presentations, attendance, lab work, etc. Their relative composition will be decided / notified by respective departments from time to time.
13. For passing each semester examination, the candidates shall be required to secure at least 36% marks in each theory paper, practical / project and; each internal assessment examination separately.
14. Candidates shall be awarded division on the basis of aggregate marks obtained in both the semester examination.
